

Mid-Florida Shetland Sheepdog Club, Inc.

Membership Level Requirements

Full Membership:

- Attend one meeting during six months prior to applying
- Fill out full membership application and give to Membership Chairman
- Have two MFSSC member sponsors complete home visit reports within the past three months
- Attend two meetings within the first six to twelve months of application acceptance
- Read and agree to standards outlined in Code of Ethics, Constitution and By-Laws
- Pay \$20.00 for single members or \$25.00 for couple membership
- Upon becoming a full member, must attend two meetings a year to maintain status

Associate Membership:

- During the six to twelve months before becoming a full member, you will be listed as an associate member, indicating to others that you wish to become a full member
- If two meetings are not attended in twelve months as an associate, membership will change to a booster membership.

Booster Membership:

- Attend one meeting during six months prior to applying
- Fill out booster application and give to Membership Chairman
- Have two MFSSC member sponsors (home visit not required)
- Pay \$15.00 for single booster membership

Membership Application

Membership Dues:

Associate Member: \$15.00; each additional family member \$5.00

Full Member: \$20.00; each additional family member \$5.00

Booster Member: \$15.00

Annual dues are payable on or before July 1st

Membership Requirements:

1. An applicant must attend at least one meeting during a six month period prior to applying for membership.
2. An applicant must complete the membership application and obtain two MFSSC members as sponsors. These sponsors are to be from different households and must have been full club members for at least one year. These two sponsors shall visit the applicant's home within three months prior to date of application and each sponsor will complete a written visit report to be submitted with the membership application.
3. Each person, after applying for Full membership, shall remain an Associate member for a minimum six month to a maximum twelve month period. Each person will need to attend at least two meetings during that time period to be eligible for Full membership by vote of the club.
4. Each applicant and family member must read and agree to abide by Code of Ethics, Constitution and By-Laws.
5. To retain Full membership status, at least two meetings per fiscal year (July 1st through June 30th) must be attended otherwise membership status will transfer to Booster membership. Several meetings each year are held on weekends specifically for the convenience of out of town members.
6. All requirements pertain to other family members applying for membership.
